#### Composition comments

Note L: The product contains special performance additives and base oils which are considered to be severely refined and not considered to be carcinogenic. All of the base oils in the product have been demonstrated to contain less than 3% (w/w) dimethyl sulfoxide extract by the IP 346 test.

### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

##### General information

### 5.1. Extinguishing media

##### Personal protection

In case of splashing or scattering, wear protective oil-resistant or chemical-resistant clothing.

##### Eye/face protection

##### Hand protection

Chemical-resistant, impervious gloves complying with an approved standard should be worn if a risk assessment indicates skin contact is possible.
